COURSES AND BIRDS

All stakes are single course without birdfield. Open Limited Gun Dog and Amateur Limited Gun Dog are retrieving stakes with the first bird shot in a designated area. When a dog is on point in this area, time out will be called and its bracemate shall be stopped. Quail released in all stakes. A blank pistol will not be fired in the Open Puppy stake.

Horseback handling is permitted in all stakes except Amateur Walking Derby.

Walking handlers will be braced together. Please indicate on your entry if walking.

RENTAL HORSES WILL NOT BE AVAILABLE AT THIS TRIAL.
